#### RE: 2011 Housing Credit Program Awards

The Ohio Housing Finance Agency (OHFA) has completed the competitive evaluation of applications submitted for the 2011 Housing Credit Program. OHFA will utilize available funding programs and resources to create financially and physically sustainable affordable housing by distributing resources through a transparent allocation process.

That process began with the review of each application by our development teams, architect, planner, and underwriting consultant. Meetings were then conducted with representatives of each applicant to become familiar with all of the housing proposals. These meetings began in early November and concluded in mid-February. In some, but not all instances, OHFA staff visited the proposed sites, with a focus on existing buildings and properties not seen previously. We also met or spoke with representatives of HUD, Rural Development and several local governments regarding their priorities.

All information gathered form these sources was used to determine whether a proposal meets the criteria indicated in the Application Process section of the 2011 Qualified Allocation Plan (QAP). Emphasis was placed on how well each proposal promotes the Policy Statements of the program. The Policy Statements used to determine which proposals to select for funding include, but are not limited to, distribution of resources to serve various populations and geographic areas; use of development subsidy and rental subsidy from outside sources; development of housing in strong markets that will be sustainable for the long term; and working with developers and management companies that have the capacity, experience and financial strength to successfully complete and operate the proposed housing. All OHFA staff responsible for reviewing applications met approximately every two weeks to discuss the proposals that they had recently reviewed, and make recommendations on whether the application should be considered for funding based on the Policy Statements. These recommendations included strong proposals for an award, acceptable proposals for funding, and applications that should not be selected.

When the application reviews and development team meetings were complete, additional staff meetings were held to determine which applications to select in each of the allocation pools based on the Policy Statements. The proposals that best promoted OHFA's Policy Statements were selected and are included on the attached list. Additional consideration was given to ensure a balanced distribution of resources based on geography and the development of housing for various populations served among all of the awards. Staff also selected proposals to place on a waiting list for any Housing Credits that may become available later in the year.

The amount of housing credits requested by each applicant has been decreased by 5% due to improvements in the housing credit equity market since the application deadline. This enabled OHFA to invest in more units and projects than would have been possible based on the original amounts requested. Credits have been awarded in each of the allocation pools up to the amount available in each pool. The remaining available funds have been awarded via the maximizing outcomes pool. Additional proposals on the waiting list may be selected for funding in the order indicated should additional credits become available later in the year.

A list of properties that received an award is enclosed, along with a summary of selections for each allocation pool, and a copy of the waiting list.
